

# SMS Privacy Policy

## Introduction

We, at the Eye Bank of Kentucky (EBKY), value your privacy and are committed to protecting your personal information. This SMS Privacy Policy explains how we collect, use, and protect your data when you opt-in to receive our SMS messages.

## Information We Collect

When you opt-in to our SMS program, we may collect the following information:

- Your phone number
- Your name (if provided)
- Any other information you voluntarily provide

## How We Use Your Information

We use the information collected to reach out in case of emergencies such as road closures, severe weather, etc.

## Data Protection

We implement a variety of security measures to maintain the safety of your personal information. Your data is stored in secure environments and is accessible only by authorized personnel.

We do not pass any individual's consent to receive SMS from EBKY to any third party. We do not share phone numbers with third parties for the purpose of allowing those third parties to send SMS.

We will never disclose personal information such as Phone numbers and SMS consent to third parties or affiliates.

## Opt-In and Opt-Out

By providing your phone number, you consent to receive SMS messages from us. You can opt-out at any time by replying "STOP" to any message you receive from us. You may also contact our customer service to be removed from our SMS list.

## Compliance with Laws

We comply with all applicable privacy laws and regulations, including the General Data Protection Regulation (GDPR) and the California Consumer Privacy Act (CCPA).

## Changes to This Policy

We may update this SMS Privacy Policy from time to time. Any changes will be posted on our website, and we will notify you via SMS if significant changes are made.

# SMS Terms & Conditions

## SMS Consent Communication

The information (Phone Numbers) obtained as part of the SMS consent process will not be shared with third parties or affiliates.

## Types of SMS Communications

If you have consented to receive text messages from the Eye Bank of Kentucky (EBKY), you may receive messages related to the following:

### **Inclement Weather**

Example: “To EBKY Staff: Please use caution when driving. There is a severe weather warning in the Louisville metro area.”

### **Road Closures**

Example: “To EBKY Staff: I64 West is closed due to an accident, please plan routes accordingly.”

### **Office Closures**

Example: “To EBKY Staff: The Lexington office is experiencing a power outage. All staff are working from home.”

## Message Frequency

Message frequency may vary depending on the type of communication. For example, you may receive up to 1 SMS message per week related to your office.

Example:

“Message frequency may vary. You may receive up to 1 SMS message per week depending on circumstance.”

## Potential Fees for SMS Messaging

Please note that standard message and data rates may apply, depending on your carrier’s pricing plan. These fees may vary if the message is sent domestically or internationally.

## Opt-In Method

All EBKY employees will be opt-in to receiving SMS messages from EBKY during the hiring and onboarding process.

### Opt-Out Method

You can opt-out of receiving SMS messages at any time. To do so, simply reply “STOP” to any SMS message you receive. Alternatively, you can contact us directly to request removal from our messaging list.

### Standard Messaging Disclosures

Message and data rates may apply.

You can opt-out at any time by texting “STOP.”
